## Net Tangible Asset Backing Per Share and 20 Largest Equity Investments at 30 June 2016

The unaudited net tangible asset backing for the Company's ordinary shares as at **30 June 2016**, before providing for capital gains tax in respect of unrealised investment portfolio gains, was **\$35.52** per share (31 May 2016: \$36.70).

The Company invests for the long term and the Board has no intention of disposing of investments other than through takeovers, mergers or other exceptional circumstances that arise from time to time. If a provision for estimated capital gains tax in respect of unrealised investment portfolio gains was deducted, the above net tangible asset backing amount of \$35.52 would reduce to \$29.32 (31 May 2016: \$30.21).

The calculation is based on the Company's interpretation of the law relating to capital gains tax and ASX Listing Rule 4.12.

Also attached is a list of the Group's 20 largest equity investments at 30 June 2016.
