**Net Tangible Asset Backing Per Share
as at 30 April 2018**

The unaudited net tangible asset backing for the Company's ordinary shares as at **30 April 2018**, before providing for capital gains tax in respect of unrealised investment portfolio gains, was **\$37.13** per share (31 March 2018: \$36.75).

The Company invests for the long term and the Board has no intention of disposing of investments other than through takeovers, mergers or other exceptional circumstances that arise from time to time. If a provision for estimated capital gains tax in respect of unrealised investment portfolio gains was deducted, the above net tangible asset backing amount of \$37.13 would reduce to **\$30.77** (31 March 2018: \$30.47).

The calculation is based on the Company's interpretation of the law relating to capital gains tax and ASX Listing Rule 4.12.
